

6	Relate information back up to co-coordinator.	
7	Liaise with Category 1 responders

ACTIONS AGREED WITH LOCAL AUTHORITY IN THE EVENT OF AN EVACUATION

Councillors, church wardens, local farmers, trustees of the Otterton Relief in Need Charity and the staff at the Old Vicarage Care Home would all be available.

ALTERNATIVE ARRANGEMENTS FOR STAYING IN CONTACT IF USUAL COMMUNICATIONS HAVE BEEN DISRUPTED

In the event of a power blackout, phones and internet would not work. The only means of communication would be to climb to the top of a nearby hill.

Clearly, if power was not affected, and land lines were still available they and internet could be used.

FLOOD WARNING INFORMATION.

Empty sand bags can be collected from either The King's Arms or 7, Bell Street or 68, Fore Street or 19, Ottery Street. Small quantities of sand can be purchased cheaply from e.g. Bradfords on Liverton Estate, Exmouth.

If you are concerned about the amount of rain that has fallen and are fearful that you may be flooded, the operations below will enable you to see the state of the River Otter.
